

How to Record a Specialist Doctor Pay Progression Review in ESR?

Background

The revised Terms and Conditions of Service Specialist (Wales) 2021, sets out that Specialist Doctors will be expected to spend a minimum of three years on each pay point and evidence specific criteria before moving to the next pay point (doctors will no longer automatically receive pay affecting increments unless the review process has been completed and a 'Yes' has been recorded for Pay Progression in ESR).

The Clinical Director / Medical Director will have the overall responsibility of ensuring processes are in place to sign off pay progression.

This document has been created to show the Clinical Manager how to progress a pay increment in ESR for a Specialist Doctor who has a 2021 Contract. The process outlined in this document does not apply to those on the 2008 Specialist Doctor Contract.

The Clinical Director will have the overall responsibility of ensuring processes are in place to sign off pay progression.


The submission process for pay progression is as follows:

- Clinical Managers will receive notification via email before a Specialist doctor's next pay progression date and initiate a meeting to review whether the requirements for progression have been met. This meeting will draw on the most recent medical appraisal and job plan review and consider the progression criteria set out in Schedule 13 of the Terms and Conditions of Service. It is not necessary to schedule appraisals and job plan reviews to coincide with pay progression dates. However, it is recommended that the Job Plan Review is held in time for the outcome of the review to be agreed between the reviewer and Doctor (please read para 35-38 of the Terms and Conditions)
- Clinical Managers must ensure that the pay progression submission process is completed in a timely fashion to ensure that pay progression can be implemented in time for the doctor's pay progression date.

N.B. Pay progression will only work if the employee (Specialist Doctor) is linked in ESR to the person carrying out the SAS Pay Progression Review meeting. Managers should review staff hierarchies in ESR to ensure they are correct and mirror the actual structures of departments. If there are managers who are responsible for undertaking pay progression reviews who require the Manager Self-Service functionality but do not currently have it, this will need to be set up in order for the managers/supervisors to use the system to record the pay progression review meeting. The ESR Proxy functionality is also an option managers should consider.

1. Log-in to ESR [NHS ESR Login](#)
2. Once you are logged-in, you will see the 'Manager' tab at the top of the screen. Please note: you will only be able to see the 'Manager' tab when you are connected to the Network or using a VPN.
3. In the Manager tab, you will see **My Team Pay Progression**.





6. Select the required Review Type of **SAS Pay Progression Review** from the **Review Type** drop-down menu.
7. Enter the start date of the review period in the **Period Start Date** field. (See note below)
8. Enter the end date of the review period in the **Period End Date** field. (See note below)

9. In the required **Template** field select **SAS Pay Progression Meeting**
10. The **Appraisal Date** defaults to today's date. Enter an alternative date in the **Appraisal Date** field if required. (See note below)
11. Enter the date of the next review in the **Next Appraisal Date** field, if known.

Important Note: The period start and end dates should reflect the 12 months **prior** to the individual's pay-affecting increment date. For example, if an employee's pay-affecting increment is due on 27th June 2022, the period start date would be 27-Jun-2021 and the period end date would be 26-Jun-2022.

The actual pay progression meeting must take place 8-12 weeks prior to the pay-affecting increment date to meet the timescales for the ESR increment process to run. In the example given above, the **Appraisal Date** would need to be no later than 1st June 2022 to meet the payroll increment timescales for June 2022.





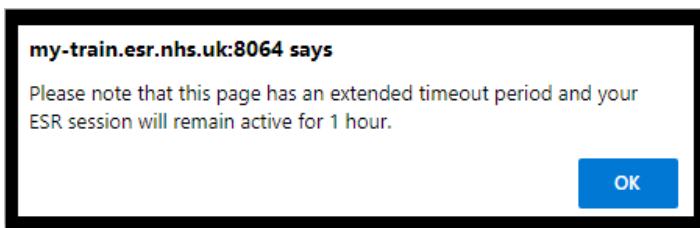

There are four sections to complete:

3. *Action Plan and Timescales* – manager and doctor to agree an action plan and timescales if the doctor does not meet the required standards
4. *Progression through Higher Threshold* – does not need to be completed as only relevant to those on a 2021 Specialty Doctors contract.

Note: after approximately 1 hour of working on the questionnaire page, the following prompt will be displayed:



15.1. Click **OK**. You must then click the **Apply** button on the Questionnaire screen before the 10 minutes have elapsed otherwise your work will not be saved.

17.1 The following 2 options are available:

1 – Yes: The employee will progress on to the next incremental point.

2 – No: The employee will not progress on to the next incremental point. No further incremental progression will be possible without intervention. In addition, a reason that the pay progression will not be applied must be entered.

There are 8 Non-Progression options to choose from in the **Reason** fields. **Reason 1** is mandatory where the Overall Rating is set to No. The other 4 reasons can optionally be completed.
